

China Visa Support Guide

Welcome to China

RedGate DMC is pleased to assist travelers and travel partners with general visa support information for travel to China.

This guide provides important information regarding visa policies, required documents, and visa-related assistance for your upcoming trip.

1. Visa-Free Entry Policy

China currently offers visa-free entry policies for eligible passport holders from selected countries.

Depending on nationality and current regulations, travelers may enjoy:

- visa-free entry
- transit visa exemptions
- short-term business or tourism access

Visa-free policies are subject to change according to official government regulations.

Travelers are advised to verify the latest requirements with the nearest Chinese embassy or consulate before departure.

2. Visa Responsibility

Travelers are responsible for:

Valid passport

Visa eligibility

Required travel documents

Compliance with immigration regulations



RedGate DMC cannot guarantee visa approval or entry permission issued by immigration authorities.

3. Passport Requirements

Please ensure:

- Passport validity of at least 6 months from travel date
- Sufficient blank visa pages
- Passport condition is acceptable for international travel

4. Visa Support Services

RedGate DMC may assist with:

- hotel confirmation documents
- itinerary confirmation
- land arrangement confirmation
- invitation support letters (where applicable)

Visa support documents are issued only for confirmed bookings.

5. Required Documents

Depending on nationality and visa type, travelers may be required to provide:

- passport copy
- flight information
- hotel confirmation
- itinerary details
- passport photo
- visa application forms

Additional documents may be requested by Chinese authorities.

6. Invitation Letter Support



For eligible bookings, RedGate DMC may provide:

Invitation Letter for Tourism Purposes

subject to:

- confirmed itinerary
- completed payment requirements
- operational approval

Issuance timelines may vary.

7. Visa Processing Time

Visa processing times vary depending on:

- nationality
- embassy location
- visa category
- seasonal demand

Travelers are advised to apply well in advance of departure.

8. Transit Visa Policies

China offers transit visa exemptions in selected cities for eligible travelers under specific conditions.

Policies may include:

- 24-hour transit
- 72-hour transit
- 144-hour transit

Conditions and eligible nationalities may vary.

Please verify eligibility before travel.

9. Important Travel Advice



Before departure, travelers should:

- Verify latest visa regulations
- Confirm passport validity
- Carry printed travel documents
- Prepare hotel and flight confirmations
- Keep emergency contact information

10. Immigration & Entry Approval

Final entry approval is determined solely by:

Chinese Immigration Authorities

at the point of entry.

11. Travel Insurance Recommendation

Travel insurance is strongly recommended and should include:

- medical coverage
- trip cancellation
- travel interruption
